IN RE: TRANSCRIPT RATE CHANGE

ENTRY AND ORDER

The General Division of the Montgomery County Common Pleas Court employs two methods for recording court proceedings: audio/video recording systems are utilized in fourteen (14) courtrooms; a court stenographer is employed in one (1) courtroom. The Court is required by law to establish procedures and rates for the preparation of transcripts from these recording methods and systems.

IT IS THEREFORE ORDERED that pursuant to Ohio Revised Code 2301.24 and 2301.25, the following page rates and procedures are established for the transcription of court proceedings. These rates and rules apply only to transcripts of proceedings that are conducted in the General Division.

1. All transcripts prepared from audio/video recording systems in the General Division shall be prepared by transcribers designated by the Court. All such requests shall be made through the Court Administrator's Office.
2. All requests for transcripts prepared from stenographic recording methods shall be made directly to the court stenographer.

TYPE 1 TRANSCRIPTS (PUBLIC FUNDS)

A Type 1 transcript is ordered on behalf of an indigent defendant and for the purpose of trial preparation, trial use, or for an appeal. Payment for such transcripts is made from public funds.

Type 1 transcripts shall be prepared, delivered or filed within time limits established by rule or statute. These rates include a Portable Document Format (PDF) version of the transcript and a

paper copy for use in trial (must be approved by the trial Judge) or for filing an appeal. Transcripts provided in PDF format shall not contain digital rights management, links to websites, advertising, or any other conventions that would limit full utilization of these documents.

TYPE 2 TRANSCRIPTS (PRIVATE FUNDS)

A Type 2 transcript is ordered on behalf of a criminal defendant or a civil party to an action for the purpose of trial preparation, trial use, or an appeal. Payment for such transcripts is made from private funds.

Type 2 transcripts shall be prepared, delivered and/or filed no later than thirty (30) days from the date the transcriber receives the recordings or the reporter receives notice of the transcript order, unless additional time is authorized by the ordering party. These rates include a Portable Document Format (PDF) version of the transcript and a paper copy for use in trial or for filing an appeal. Transcripts provided in PDF format shall not contain digital rights management, links to websites, advertising, or any other conventions that would limit full utilization of these documents.

ADDITIONAL SERVICES (TYPE 1 AND 2 TRANSCRIPTS)

Additional services may be provided by the transcriber or court stenographer. The cost of additional services will be determined between the ordering party and the transcript provider. If

these items are ordered on behalf of an indigent defendant, the expenditure must be preapproved by the trial Judge.
