



GENERAL CONDITIONS OF SUPERVISION

- _____ 1. I agree that I will obey all local, state and federal laws, and that I shall immediately contact my Probation Officer if arrested or questioned by a law-enforcement officer.
- _____ 2. I agree that I will not purchase, own, possess, use, or have under my control, a deadly weapon (e.g., switch blades or ballistic knives, bow and arrows, brass knuckles, swords, straight razors, martial arts style weapons) or firearm, and acknowledge that knives and box cutters are not permitted in the office or the Courthouse.
- _____ 3. I agree that I will notify my Probation Officer of any change of residence immediately after the change, and that I will not leave the State of Ohio without the written permission of the Court or my Probation Officer.
- _____ 4. I agree that I will regularly work at a lawful occupation and support my legal dependents, if any, to the best of my ability, that I shall notify my Probation Officer as soon as I become unemployed, and that I will consult my Probation Officer prior to job changes.
- _____ 5. I agree that I will report at such time and place as directed by my Probation Officer. If my Probation Officer is unavailable, I will report to the Officer-of-the-Day, the Supervisor, the Manager, or the Director of Probation Services.
- _____ 6. I agree that I will not use or possess any alcohol, controlled substances, drugs of abuse, or drug substitutes except as prescribed by a physician and specifically approved by the court. I consent to drug and alcohol testing to determine if I have violated this condition. I understand that I will be observed by a Probation Officer when submitting urinalysis samples. All medications that I use will be kept in the original prescription bottle or packet.
- _____ 7. I agree that I will accomplish all case plan objectives, which are now, or will be set for me throughout my supervision.
- _____ 8. I agree that I will not be in any building, structure, room, vehicle or place when I know or have reasonable cause to know that any illegal drugs, stolen property, or firearms are present.
- _____ 9. I agree that I will not possess stolen property or contraband, including ammunition, explosives or explosive devices, chemical agents (such as mace), electronic weapons (such as Taser), or body armor.
- _____ 10. I agree that I will not enter into any agreement to act as an informer or special agent with a law enforcement agency without written permission of the Court.
- _____ 11. I agree that the Court may order me to be screened for the MonDay Community Correctional Facility or other residential sanction in accordance with ORC 2929.16 (Residential Sanctions), and that I shall comply with all screening requirements.
- _____ 12. I agree that during my period of supervision, authorized Probation Officers who are engaged within the scope of their supervisory duties or responsibilities and who have reasonable grounds to believe that I am not abiding by the law or otherwise am not complying with the conditions of my supervision or other sanction may search, with or without a warrant, my person, my place of residence, my motor vehicle, item of tangible or intangible personal property or real property in which I have a right, title, or interest, or for which I have the express or implied permission of a person with a right, title, or interest to use, occupy, or possess.

_____ 13. I agree and consent to having any electronic device that I have access to, including a cell phone, personal computer, laptop, or any other device that stores electronically stored information, searched without a warrant by authorized Probation Officers who have reasonable grounds to believe I am not abiding by the law or otherwise am not complying with the conditions of my supervision or other sanction. I will provide the password to unlock any such device if instructed to do so by authorized Probation Officers.

I understand that the Court may change the conditions of my supervision, reduce or extend the period of supervision, may issue a warrant and extend the period of supervision, or impose a more restrictive sanction or prison term for violation of one or more of the conditions of my supervision. I have read or had read to me, the above conditions of supervision, and I fully understand them, and I will abide by them.
